

Final Paper Preparation and Submission Guidelines:

- Full Paper Template
 1. Papers submitted to PEDG 2021 should follow the Final Paper Template on the PEDG 2021 website
 - The page limit is 8 pages
 - The format style including the lay-out and font sizes of the final submissions should strictly follow that of the template.
- Copyright Clearance Code
 1. The appropriate copyright clearance code notice is to appear on the bottom of the first page of each paper following the instructions below:
 - For papers in which all authors are employed by the US government, the copyright notice is: U.S. Government work not protected by U.S. copyright
 - For papers in which all authors are employed by a Crown government (UK, Canada, and Australia), the copyright notice is: 978-0-7381-4237-1/21/\$31.00 ©2021 Crown
 - For papers in which all authors are employed by the European Union, the copyright notice is: 978-0-7381-4237-1/21/\$31.00 ©2021 European Union
 - For all other papers the copyright notice is: 978-0-7381-4237-1/21/\$31.00 ©2021 IEEE
- Registration Payment:
 1. YOU ARE EXPECTED TO REGISTER BEFORE YOU CAN BEGIN THE FINAL SUBMISSION PROCESS. You will receive a confirmation code once you have successfully registered, this confirmation code is needed for final paper submission.
 2. A limit of one paper is allowed to be associated to one paid registration, with an additional paper allowed if an additional fee is paid.
 3. In order to guarantee inclusion in the conference program one author must be registered by April 30, 2021 23:59 (GMT -0700), the author deadline.

- Submission Requirements

1. The paper template and guidelines are uploaded at: <https://ieeepedg.org/manuscript-preparation-and-submission-instructions/>. Please strictly follow the template and guidelines.
 2. You must virtually present your paper, whether to it is an oral or poster presentation, to have your paper published to the IEEE Xplore digital library. If you do not virtually present for any reason, your paper will be excluded from Xplore.
 3. Your full paper in PDF format must be submitted no later than April 30, 2021 23:59 (GMT -0700) at this web site: PEDG 2021. Your paper must comply with the specifications given in your acceptance email and available on the PEDG 2021 web site. No time extensions will be granted.
 4. The uploaded version of the full paper is considered final and may not be changed for any reason if the final submission data has passed (April 30, 2021 23:59 (GMT -0700)). The final version must be virtually presented at the conference and will be submitted to IEEE Xplore for permanent archive. NO REQUESTS FOR MANUAL UPDATES TO YOUR FINAL SUBMITTED MANUSCRIPT WILL BE ACCEPTED.
 5. Your completed IEEE copyright release must be filed by April 30, 2021 23:59 (GMT -0700). You must log into your author account to access the copyright release form for your accepted paper and follow given instructions. This will begin the digital filing process for your copyright release.
 6. Your final paper will be submitted for plagiarism checking to the IEEE Crosscheck system.
- Important Xplore Compliance Procedure
 - The PDF submission of the full paper must be IEEE Xplore compliant to be included in the PEDG 2021 Proceedings and IEEE Xplore. Thus, you must FIRST ensure that the PDF file of the full paper is compliant by using the IEEE PDF eXpress system BEFORE submitting your paper to the conference final submission web site (that opens up on March 21, 2021). The instructions are the following:Go to the IEEE PDF eXpress web site: www.pdf-express.org

 3. Use PDF eXpress to check or create your PDF file

4. The eXpress-compliant PDF file of the full paper must be submitted to PEDG 2021. There are two separate procedures: (a) checking your PDF file for eXpress compliance and (b) submitting your final paper for publication. Your eXpress-compliant file must be submitted to the PEDG 2021 to be include in the conference proceedings and IEEE Xplore.
